## Guidelines:

- Late application forms will be accepted, either for students who reach a graduation level after the application deadline but before the
  recording is due, or for those who decide to make a recording after the application deadline, however, late recordings will NOT be accepted
  after the recording submission deadline.
- Each graduation recording will be evaluated by one teacher
- Each student will receive a comment form from the evaluating teacher
- Every student will pass the graduation requirements if they have reached the required level of study, the appropriate pieces have been
  recorded, the student's teacher has approved the recording, and the recording was submitted by the deadline.
- All violin, viola and cello recordings must be recorded with piano accompaniment. (The accompaniment tracks on the Suzuki recordings will be allowed as an acceptable substitute for a live accompanist)
- Students may fulfill graduation requirements for more than one level at one time
- All students will perform, as a group, all the pieces required for their level at the graduation concert
- Each student will be presented with a graduation certificate and a keepsake award of the occasion
- Students must participate in the rehearsal to perform in the concert
- All music must be memorized
- Only audio recordings will be accepted. Tracks on the recording must be in the same order as the pieces in the Suzuki repertoire.
   Acceptable media: flash drive/thumb drive with .mp3 audio files or an audio CD or DVD. If an online video sharing site must be used (YouTube, Vimeo, etc.) the video must be recorded with the camera facing a blank wall or a piece of black fabric or paper, where the performer is not in view. The recording is to be an AUDIO recording only.
- Please label your CD with your name, address, instrument, graduation level(s), and your teacher's name. CDs will be returned to each student at the graduation concert
- There will be no refunds.
